Rules and Regulations for Far Hills Association Mooring Permits

- 1. Only boats with a valid Massachusetts registration in the name of a Far Hills Association (FHA) Back Lot Owner will be issued a Mooring Permit. Only those FHA Boats that have been issued permits are allowed to moor in the designated area.**
- 2. FHA Waterfront Lot Owners do not qualify for FHA Mooring Permits**
- 3. Only FHA Members in good standing or with an approved dues payment plan may hold an FHA Mooring Permit.**
- 4. If all FHA Mooring Permits are issued, applicants will be placed on a waiting list in the order the applications are received.**
- 5. FHA Mooring Renewal Permits will be issued by May 30th. If applications are received after May 30th, mooring spot will be assigned to the next member on the waiting list.**
- 6. FHA Mooring Permits are for the mooring of boats only the designated and assigned mooring area. Other uses and actions shall not be permitted in the designated mooring areas, including but not limited to: fishing; picnicking; loitering; storage of materials, fuel, or boating equipment; etc.**
- 7. FHA Mooring Permit Holders must follow all FHA, state, and federal boating rules, regulations, and requirements. The FHA and its Directors assume no responsibility or liability for any boats, equipment, or property the mooring area, or for the actions of anyone on or using FHA property or the boats.**
- 8. FHA Mooring Permits can be revoked or not renewed if these rules and regulations are not adhered to, or if the docks, mooring sites, or boats are not properly maintained.**
